Deadline: August 30, 2019

All exhibitors are required to submit a Certificate of Insurance (COI) or sign and submit the below Insurance Waiver.

If providing a Certificate of Insurance, the certificate must name **FACSS/SciX Conference, Talley Management** and the **Palm Springs Convention Center**, their respective directors, officers and employees as additional insureds. INSURANCE WAIVER

THIS WAIVER AND RELEASE is made by _____ (“Exhibitor”) in favor of the Federation of Analytical Chemistry and Spectroscopy Societies (FACSS) and SciX 2018

INTENT

(1) **THIS WAIVER AND RELEASE MUST BE PROVIDED TO THE CONFERENCE BY AN EXHIBITOR WHO, AFTER MAKING REASONABLE ATTEMPTS, IS NOT ABLE TO PROVIDE THE CONFERENCE WITH A CERTIFICATE OF INSURANCE AS PREVIOUSLY REQUESTED.**

(2) **AS SIGNATORY TO THIS WAIVER AND RELEASE, EXHIBITOR ASSUMES ALL RESPONSIBILITY FOR AND RELEASES FACSS FROM ALL CLAIMS AS DESCRIBED BELOW ARISING FROM THE EXHIBITOR’S PARTICIPATION IN THE SciX 2018 CONFERENCE.**

CONDITIONS

- (1) Waiver and Release: The Exhibitor assumes all responsibility for and all risk of any damage or injury whether to property or person, including death that may occur to the Exhibitor, its employees, agents, licensees, or invitees at or in connection with the Event. The Exhibitor agrees to protect, save and hold SciX, FACSS, its Governing Board, Talley Management, the Palm Springs Convention Center, and all agents and employees thereof (hereinafter collectively called Indemnities) forever harmless for any damage or charges imposed for violations of any law or ordinance, whether occasioned by the negligence of the exhibitors or those holding under the exhibitor, and further, the exhibitor shall, at all times, protect, indemnify, save and hold harmless the indemnities against and from any and all losses, costs, damages, liability or expenses (including attorney’s fees) arising from or out of or by reason of any accident or bodily injury or other occurrences to any person or persons, including the exhibitor, its agents, employees or business invitees, which arise from or out of or by reason of said exhibitor’s occupancy and use of the exhibition premises.
